NEW BUSINESS

A. Skylight Project Completed

Keefe informed the Board that the project has been completed. It took a slightly longer than expected due to the heat. The project went smoothly. The glaze on these skylights will lessen the fading of our furniture and materials.

B. Library Opening Update

Keefe updated the Board on the reopening. There have been very few reminders needed for masks. If someone did forget theirs, they were gracious that we were able to supply them with one. The Lobby Attendants did use a counter to monitor people coming in and leaving the Library. We did not get close to capacity. Staff felt comfortable as there were many reminders for all to maintain a safe social distance.

C. Next Phase: Service Levels and Facility Safety

The revised hours of the Library will remain at least through August. Keefe will determine how and if this needs to change to accommodate school resuming. Staff will no longer be working in teams beginning in August. This will allow for much easier scheduling. Most of our peer libraries are providing the same services and hours that we are. Bloomfield and Keefe have been reviewing options we can use to improve the air quality in the building. Staff have been given fans to use for the work spaces. Keefe is working with Oak Brook Mechanical to improve the filtration system.

TRUSTEE'S COMMENTS
